This Indenture made this thirtieth Day of December one thousand seven Hundred & Sixty.
Benjen Martha Lewis & James Lewis Esrs of Joshua Lewis Deed of the one part
and Samuel Pete of the County of Sussex Practiser of Physick of the other Part -
Whereas the s^d. Joshua did in his Lifetime agree with the s^d. Samuel Pete for the
Purchase of the Plantation Tract or Parcel of Land whereon the s^d. Joshua then Lived containing
by Estimation one Hundred Acres more or less But before the Deed for the s^d. Land was executed the
said Joshua departed this Life having first made his last Will & Testament & thereby directed his said
Land to be sold. but whereas since the Death of the s^d. Joshua who had received thirty Pounds
more or less of the Consideration Money of the s^d. Land in his Lifetime the s^d. Martha & James Lewis
wherein his Will appointed by his said Will have proved the same according to Law And the s^d. Samuel
Pete hath commenced a Suit in Chancery in the County Court of Southampton to enforce the Perform-
ance of the agreement aforesaid with the s^d. Joshua made in his Lifetime which Suit was so far
Proceeded in that a Court held for the said County on Thursday the 11th Instant it was decreed and
Ordered that the said Martha Lewis & James Lewis should convey the s^d. Land to the s^d. Samuel
Pete on his Paying thirty Pounds the residue of the Consideration Money according to the Agreement
between them of the s^d. Joshua in his Life Time Now this Indenture Witnesseth that in Pursuance
of the s^d. decree and also for & in Consideration of the Sum of thirty Pounds to the s^d. Martha Lewis &
James Lewis in hand Paid also before the Sealing & Delivery of these Presents the receipt whereof they
do hereby Acknowledge and thereof Acquit & Discharge the s^d. Samuel Pete his Heirs & assigns
forever by these Presents They the s^d. Martha Lewis & James Lewis Have Granted Bargained
