This Indenture made this Ninth Day of July In the year of our Lord Christ one thousand seven hundred and sixty one Between Isaac Pope of the County of Southampton of the one Part and William Pope of the same County of the other Part Witness that the said Isaac Pope for and in Consideration of the Sum of twenty two Pounds five Shillings Curr^t Money of Virginia to the s^d Isaac in hand Paid by the s^d W^m Pope at or before the sealing and Delivery of these Presents to the Receipt whereof the s^d Isaac Pope Doth hereby acknowledge Hath granted Bargained Sold Aliened Enfeoffed and Confirmed and by these Presents Doth Grant Bargain Sell Alien Enfeoff and Confirm unto the s^d W^m Pope and to his Heirs and Assigns forever a Certain Tract or Parcel of Land and Premises with the Appurtenances Situate lying and being in the s^d County of Southampton Containing by Estimation one hundred Acres more or less and Bounded as followeth Beginning at a white Oak on the west side of a Branch a Corner of W^m Edwards Land thence by his to a red Oak over the turn of the Meadows Branch a Corner Tree of Henry Papes Land thence up the turn of that Branch to a red Oak a line Tree of the Notaway Indians Land a Corner of Henry Papes Land thence by the said Indian Land to a live Oak by the side of the Branch begun upon and down the s^d Branch to the first Station the s^d Tract of Land being the whole of a Parcel made to Francis Cox by Anthony Franco bearing Date the fifteenth Day of December 1760 And all Houses outhouses Edifices Buildings Yards Gardens Woods Trees Ways waters Water Courses Profits Commodities Hereditaments and Appurtenances to the said Tract or Parcel of Land and Premises with the Appurtenances belonging or in anywise Appertaining and the Reversion and Reversions Remainder and Remainders Tenths Fees and Profits thereof and every Part and Parcel thereof and all the Estate Right Title Interest Property Claim and Demand of him the s^d Isaac Pope of and to the s^d Land To have and to hold the s^d Tract or Parcel of Land and Premises with the Appurtenances unto the said W^m Pope and to his Heirs and Assigns to the only proper use and behoof of the s^d W^m Pope his Heirs and Assigns forever And the s^d Isaac Pope for him self his Heirs Executors and Administrators doth Covenant Promise and Grant to and with the s^d W^m Pope his Heirs and Assigns forever by these Presents that he the said Isaac Pope and his Heirs the s^d Tract or Parcel of Land and Premises with the Appurtenances unto the s^d W^m Pope his Heirs and Assigns against all and every Person or Persons whatsoever lawfully Claiming
