in hand Paid by the said Isaac Pope at or before the Ensealing and Delivery of these
presents the Receipt whereof the s^d W^m Pope Doth hereby acknowledge He hath
granted Bargained Sold Aliened Enfeoffed and Confirmed and by these Presents
Doth grant bargain Sell alien on feof and Confirm unto the said Isaac Pope and to
his Heirs and assigns forever a certain Tract or Parcel of Land and Premises with the
appurtenances lying & being in the County of Southampton containing by Estimation
Two hundred and Sixty one Acres be the same more or less and bounded as followeth
Beginning at a Hickory a Corner of A. W. In the Indian Branch line
Running along the said line North 45 East 17 1/2 Pole to a Hickory in the
said line thence North 45 West 2 1/2 Pole to a Pine South 45 West 17 1/2
Pole to a nother Pine South 45 East 2 1/2 Pole to the Beginning which said
Tract or Parcel of Land was Surveyed for the Nottoway Indians November 9th 1756
by them and Truster Sold to the s^d W^m Pope party to these Presents And all
