and sixty two Between Thomas Williamson of the Parish of Nottoway in the County
of Southampton of the one part and John Britt of the same Parish & County Planter
of the other part Witnesseth that the said Thomas Williamson for and in Consideration of
the sum of forty seven Pounds current Money of Virginia to him in hand Paid by the
John Britt the Receipt whereof he doth hereby Acknowledge and thereof Acquit and
Discharge the sd John Britt hath Granted Bargained and Sold Aliened Infeoffed and
Confirmed and by these Presents Doth Grant bargain Alien Infeoff and Confirm unto
the sd John Britt and to his Heirs and assigns forever all that Tract or Parcel of Land
Situate lying and being on the North Side of Black Water Swamp in the Parish
City aforesaid Containing by Estimation one Hundred and seventy five Acres betwixt
same more or less and bounded as followeth Beginning at the Corner of Blackwater
Swamp at the mouth of the Spring Branch line of John Mesters and along the said
Mesters Line to a mark Pole on the Head of the sd Branch and from thence along the
to a Dogwood corner Tree of the said Mesters joining to Wm Jones's Line and from thence
along the sd Jones's Line to a line a corner Tree of the said Jones's Line and from thence
