This Indenture made this 12th day of January in the year of our Lord Christ one thousand seven hundred sixty two Between William Rose and Martha his wife of the parish of Nottonway and County of Southhampton of the one part and Thomas Moore of the same parish & County of the other part Witnesseth that the said William Rose and Martha his wife for and in consideration of the sum of fifty six pounds three shillings and three pence by the said Thomas Moore to them in hand paid at or before the making and delivery of these presents the receipt whereof they do hereby acknowledge and thereof acquit and discharge the said Thomas Moore his heirs & assigns forever by these presents have granted bargained and sold alien released and confirmed and by these presents do grant bargain and sell alien release and confirm unto the said Thomas Moore and to his heirs and assigns forever All that the said William Rose & Martha their plantation tract or parcel of land situate lying and being in the said parish & County containing two hundred acres be the same more or less purchased by the said William Rose of one Edmund Pate bounded as followeth to wit beginning at a red oak sapling in John Pitmans line thence north northeast thirty eight poles to a lightwood post in Owen Mynches line thence by the said Mynches line north thirty degrees West nineteen poles to a pine and North ten degrees west one hundred and fifty six poles to a pine thence north eighty degrees west one hundred poles to a pine and north seventy degrees west ninety four poles to a red oak a corner of David Wiggins's land thence by the said Wiggins's line south fifty degrees west sixty poles to a lightwood post a corner of Thomas Wiggins's land thence by the said Wiggins's line south fifty degrees east one hundred and thirty poles to a pine and south five degrees east sixty four poles to a red oak a corner of John Pitmans land thence by the said Pitmans line south fifty six poles to a red oak south east thirty
