This Indenture made this 10 day of October in the year of our Lord Christ one
thousand seven hundred & sixty four Between John Council and Sarah Council the wife
of John Council of Southampton county of the one part and Salathiel Lewis of the same
county of the other part: Witne be it that the said John Council and Sarah Council his
wife for and in consideration of the sum of twenty nine pound three shillings current
money of Virginia to them in hand paid by the said Salathiel Lewis the receipt whereof
the said John Council and Sarah Council his wife doth hereby acknowledge
and hath granted bargained and sold aliened enfeoffed and confirmed and by these
presents doth grant bargain and sell alien enfeoff and confirm unto the said
Salathiel Lewis and to his heirs and assigns forever one certain tract or parcel of
land lying and being in the county of Southampton aforesaid twenty four acres
more or less and bounded as followeth to wit beginning at the mouth of the line
branch that divides between me and Francis Benson up the said branch to the
head, so along a line of marked trees to the old side line as in corner tree, between
Benson's Eastward up that line to Borne Branch then down that said branch to a gum
corner tree, then west along of marked trees to a pole in a small branch and down in the
that to the line Branch before mentioned the first station of the said land was by
patent granted to John Benson the elder by Alexander Spotswood his Majesty's
Lieutenant Governor of Virginia and transferred from Benson to John Schief from John
Schief to son Joshua Schief and from Joshua Schief to Hodges Council with all houses
improvements gardens orchards and all other improvements woods undrained way water
and water courses with all the appurtenances thereto belonging or in anywise appertaining
To have and to hold the premises together with all their appurtenances there
to belonging to him the said Salathiel Lewis and his heirs and assigns forever the
said John Council & Sarah Council his wife vnder right in the said premises
and have lawful title to dispose of the same & conveyed from all former deeds sales
bargains gift grants right or title of Dower to the only proper use behoof of the said
Salathiel Lewis and his heirs & assigns forever according to the true intent meaning
of these presents and the said John Council, Sarah Council his wife all the above
twenty four acres of land more or less with all houses and its appurtenances from the
claim of them the said John Council and Sarah his wife or either of their heirs
to the only aforesaid Salathiel Lewis and his heirs & assigns vnder warrant
