Eng^l to him in hand paid at or before the executing of & delivery of these presents
the receipt of which and himself fully satisfied contented and paid he doth
hereby acknowledge hath granted bargained & sold aliened & confirmed and by these
presents doth give grant Bargain & sell Alien and confirm unto the said John
Cobb his heirs and assigns forever all that tract or parcel of land lying and
being on the county of Southampton aforesaid and bounded as followeth
Beginning at a pine in round hill swamp a corner of Ogton Branch's land along his
line N. 12. W 60 pole to a white oak then N. 82. W 12 pole to a white oak a corner
of the said Branch's then along to Gray's line South 28. E 212 pole to a turkey oak
a corner of Benj. Coopers Land then a small branch then down that by the meanders
round hill swamp then down the swamp by the meanders to the beginning also all woods
under woods ways water & water courses with all profits commodities & advantages
whatsoever to the same belonging or in any wise appertaining and also the reversion
and adversion remainder & remainders next & several of all the premises and of
every part thereof & also all the estate right title interest claims & demands whatsoever
to him the said Henry Blow of in and to the same premises and every part thereof
To have and to hold all and singular the said premises above mentioned and
every part and parcel thereof with their appurtenances unto the said John Cobb
his heirs and assigns forever of the said Henry Blow for himself his heirs & the
above mentioned premises and every part thereof against him of his heirs and
