 Southampton of the one part and Joseph Pope of the same county of the other part
 Witneseth that the said William Pope for and in consideration of the sum of twenty pound
 current money to him in hand paid at or before the sealing and delivery hereof the receipt
 whereof is hereby acknowledged and the said Joseph Pope thereof he the said W^m Pope
 doth hereby acquit and discharge hath granted bargained sold and by these presents doth
 fully and absolutely grant bargain sell enfeoff release and confirm unto the said Joseph
 Pope his heirs and assigns one certain tract or parcel of land lying and being in Southampton
 county on the south side of Tochnabathienty swamp containing by estimation two hundred
 acres be the same more or less and bounded as followeth Beginning at poplar in William Edwards
 line by the side of Edwards branch thence by the said Edwards line to a hickory and
 along the said line to a spanish oak a corner of the said Edwards land stand on Tochnabathienty
 swamp and up the said swamp to a live oak a corner of Jose Pope land and along the
 said Pores line to a small maple standing in the said Edwards branch and down the said
 branch to the beginning together with all houses and buildings thereon with the reversion of several
 remainder and remainders rents issues and profits thereof and every part or parcel thereof
 the appurtenances to have and to hold all and singular the said land above mentioned and all
 part and parcel thereof unto the said Joseph Pope his heirs and assigns forever and the said
 William Pope for himself his heirs executors and administrators the said land and premises and every
