Bell Executors as aforesaid by written authority of the last Will and Testament of J. T. Batts dec. and for the consideration of their hundred dollars, do hereby grant and convey to the said Spradley Simmons the tract of land purchased by the late Edward Batts, do from John Simmons, it being the tract on which the said John Simmons resided at the time of his death, containing by estimation four hundred and thirty seven acres. and the said W^m W.
