This Deed made this 26th day of October in the year of our Lord eighteen hundred and sixty two between Augustus Crumpler and Virginia R Crumpler his wife of the County of Southampton and State of Virginia of the one part and Edward C Crumpler of the same County and State of the other part Witnesses, that the said Augustus Crumpler and Virginia R his wife for and in consideration of the sum of Two thousand dollars to them in hand paid by the said Edward C Crumpler at or before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained and sold, and by these presents do grant, bargain and sell unto him the said Edward C Crumpler his heirs and assigns forever one certain tract or parcel of land situate lying and being in the aforesaid County of Southampton and Parish of Saint Lukes, containing by estimation two hundred and ninety five acres, be the same more or less (it being the tract of land which the said Augustus Crumpler purchased of the said Edward C Crumpler a few years ago) and bounded by the lands of the said Edward C Crumpler and John B Jenkins and by Watkinson River To have and to hold the above described tract or parcel of land and premises with all the appurtenances thereto belonging, or in any wise appertaining, unto him the said Edward C Crumpler his heirs and assigns forever to and for the only proper use and behoof of him the said Edward C Crumpler his heirs and assigns forever. And the said Augustus Crumpler and Virginia R his wife, for themselves, their heirs, executors and administrators do and each of them doth hereby covenant and agree to and with the said Edward C Crumpler his heirs, executors, administrators and assigns, that they will by these presents warrant and forever defend all the right and title of the aforesaid tract or parcel of land, and every part or parcel thereof against the claims or demands of all and every other person or persons whatsoever. In Witness whereof the said Augustus Crumpler and Virginia R Crumpler have hereunto set their hands and affixed their seals the day and year first above written.
