Butts dec^d of the one part, and John Cobb of the other part, all of the County of Southampton and State of Virginia: Witnesseth, that by virtue and authority of the last Will and Testament of the said J. T. Butts dec^d and in consideration of the sum of twenty six hundred and thirty dollars, the Wm W Cobb and Wm A Bell Executors as aforesaid do grant and convey unto the said John Cobb all of the tract of land belonging to the said J. T. Butts dec^d which was purchased by his father Edwards Butts from G. C.
