This Deed made the eighteenth day of November in the year one thousand eight hundred and sixty five,
between James T. Harrison of the first part and Sarah R Holt of the other part, both of the County of
Southampton and State of Virginia Witnesses; that whereas the rites of matrimony are designed shortly to
be solemnized between the said James and the said Sarah, and whereas the said Sarah is single and
possessed of a large real and personal estate, all of which the said James is desirous should be held, possessed,
controlled and enjoyed by the said Sarah after their marriage, to the own, exclusive separate use and benefit
of the said Sarah, in all respects, as if she were a feme sole - Now this Deed Witnesses that the
said James Harrison doth hereby forever relinquish, forego and quit claim to all right, title and interest in
law or equity, present and future, in or to any and all kinds of property, or estate, real, personal or mixed of
which the said Sarah R Holt may now be seized or possessed or may hereafter acquire, to wit: all the
dower interest of the said Sarah in the estate real & personal of the former husband of the said Sarah R Holt
(to wit: James T. Holt) all of the real estate of the said Sarah held in fee, for years or otherwise, stock of
horses, (four head) cattle, hogs, and all increase from the said several kinds of stock, crops of all kinds, corn,
fodder, peas, cotton and brandy, household and kitchen furniture and utensils of all kinds, brandy, Still casks
and fixtures, carts, plows and farming implements of all sorts, one buggy and all monies and evidences of indebted-
ness to the said Sarah whether due by bond, open account or otherwise. And the said James Harrison
hereby agrees and covenants that the said Sarah R Holt may and shall, either during their courtship or
marriage, by Deed of Bargain and Sale or by her last Will and testament, by deed of gift or otherwise dispose
of any or all of her said property, real, personal or mixed now in her possession or which she may hereafter
acquire, in all respects as if she were a feme sole or single woman. And the said Sarah R Holt hereby
covenants and agrees that the said James Harrison may and shall either during the said courtship or
marriage, by Deed of Bargain and Sale, by Deed of gift, by his last Will and testament or otherwise dispose of any or all of the
property, real, personal or mixed, of which he may now be seized or possessed or which he may hereafter acquire,
in all respects as if he were an unmarried man, hereby relinquishing all right of dower which she might otherwise
have or claim in or to any estate of every kind whatsoever which the said Harrison may now possess or
hereafter acquire -
