Story and their heirs and assigns forever, one certain tract or parcel of land, situate lying and being in the aforesaid County of Southampton and parish of Saint Lukes, containing by estimation one hundred and twenty-four acres be the land more or less, and bounded by the lands of Little St. Bishop, Archer Vicks heirs, and others - together with all and singular its appurtenances thereto belonging, or in any wise appertaining - To have and to hold the above described tract, or parcel of land and premises with its appurtenances as aforesaid unto them the said Edmund R. Story and Joshua T. Story and their heirs and assigns forever, to and for the only proper use and behoof of them the said Edmund R. Story and Joshua T. Story, their heirs and assigns forever. And the said Miles Story for himself, his heirs, executors and administrators, doth hereby covenant and agree to and with the said Edmund R. Story and Joshua T. Story, their heirs, executors and administrators and assigns, that he will by these presents warrant and forever defend all the right and title of the aforesaid tract or parcel of land and premises, and its appurtenances and every part and parcel thereof, against the claims or demands of all and every other person or persons whatsoever.
