 use of purpose & none that, that is to say, if the said E. J. Hill his Executors or Admin^r shall at any time
 after a demand made for either or all the aforesaid bonds as specified in this trust shall fail or refuse
 to pay the same so that payment shall be required of the said James Barnes Executor of Mason Hill by
 the aforesaid creditors, then so soon after such demand of payment shall be made as the said James
 Barnes Esq. shall require him the said E. J. Hill with trustee so to do, he the said Alex. Birt shall
 proceed to sell upon the premises to the highest bidder for cash or otherwise all the property herein conveyed
 after giving ten days notice in the County or parish where the land lies, and out of the proceeds of such
 sale he shall pay all the costs and charges attendin the execution of this trust, then pay the entire
 amount that may then be due on any one or all three of the aforesaid bonds and if the said James
 Barnes Executor shall have disposed of the said sum or any part thereof on the bond or bonds above named
 in that event the said Alex. Birt out of the proceeds of the said sale shall pay to the said James
 Barnes Esq. all such sum or sums of money as he shall have paid in discharge of the said bond or bonds that
 he may have paid in consequence of Mason Hill having become so bound in the bonds aforesaid as surety
 of the said E. J. Hill & all balances if any he shall pay to the said E. J. Hill his heirs, executors or

 between George W. Lawrence (grantor) of the first part, and John Moore (grantee) of the other
 part, both of the County of Southampton, Westchester, that the said grantor for and in consideration
 of the sum of fifteen hundred dollars to the said grantor by the said grantee paid the receipt of which
 said sum is hereby acknowledged, do the sell, grant, and convey to the said grantee, the following
 property, real and personal to wit: all that tract of land on which the said Lawrence now resides
 containing two hundred & sixty six acres, more or less, and bounded by the lands of William Cobb,
 Clay Bryant, Benjamin Dwyer, James Suther's & others. One bay horse and two mules, nine head
 of cattle, four sheep, thirty five hogs, all the farming implements now in possession of the said
 Lawrence including one wagon and one cart and one buggy and the household
 and kitchen furniture now in possession of the said Lawrence - all the corn and fodder now
 on hand - and all the growing crops of every kind, to wit: corn, fodder, wheat, oats, rye, potatoes,
 peas cotton &c. And the said George W. Lawrence warrants generally the property hereby conveyed
