

This deed made the 1st day of February eighteen hundred and sixty six between William J Robinson and Cornelia W Robinson his wife of the County of Greenville and Joseph H Primes of the County of Southampton all of the State of Virginia. Witnesses that in consideration of five hundred dollars the said William J Robinson and Cornelia W his wife do grant unto the said Joseph H Primes all their right and title to twenty five acres of land (more or less) lying in Southampton and Greenville Counties and bounded by the public road the said Primes land and the land of David Primes dec^d also the said Robinson & wife grant unto the said Primes all their right and title to wd. the title of Mary Rebecca and Marcus Clarke, in the land now owned by said J. H. Primes during Bay Clarke's life. The grantors covenant with the grantee that they will warrant generally the property hereby conveyed. Witness the following signatures and seals.

M. Gurley does by these presents bargain sell & convey unto the said Patsy Jenkins one cut and tract or parcel of land containing about eighty acres, be the same more or less bounded by the lands of Jno. Ellis James Griffin & others, it being the same tract formerly owned by James J Williams. To have and to hold the said tract of land to her heirs forever, free from the claim of the said Jno. M.
