Wills, grantee, of the other part both of the County of Southampton and State of Virginia. Witnesseth, that the said Mary A. Wills, for and in consideration of the sum of Five hundred dollars (\$500) in hand paid by the said John T. Wills, the receipt whereof is hereby acknowledged, doth grant and convey unto the said John T. Wills, all that tract of land lying in the County of Southampton on which she now resides, containing about three hundred and sixty acres more or less, and bounded by the lands of Levi Huddleston estate, Mr. Drake, Amos Joyner, Elijah Harris and Buchanan's Doyal, the said lands to have and to hold to him and his heirs forever. And the said Mary A. Wills, doth warrant generally the property hereby conveyed. Witnesseth the following signatures and Seal the day and year aforesaid
