This deed made this 13th day of April A. D. 1866 between Wm. H. Spratley Commissioner appointed by the County Court of Southampton, in the case of Miller agt. Miller's admors. to sell the real estate of which Nancy Miller died seized of the first part and James Scarborough of the County of Southampton of the second part. Witnesseth that the said Spratley Com. sold the land of which Nancy Miller died seized to the highest bidder according to the terms of the decree above mentioned and James Scarborough became the purchaser at the sum of fifty hundred and fifty dollars, which sum the purchaser has fully paid.
