This Deed made this 10th day of October in the year of our Lord one thousand eight hundred and Sixty-five; Between Nicholas J Battle of the County of Southampton, State of Virginia, of the one part, and James W Battle of the County of Hartford, State of N. Carolina of the other part. Witnesseth, that the said Nicholas J Battle for and in consideration of the sum of two hundred dollars, hath bargained and sold, and by these presents doth bargain & sell unto the said James W Battle, his heirs and assigns, all of his right, title, interest and claim to and in one certain piece or parcel of land lying in the County aforesaid County of Southampton, immediately on the N. Carolina State of line, and is that tract, or parcel of land allotted and set apart to John A Battle in the division of the lands of his father, the late William R Battle deceased and of which the said John A Battle died single and professed; to one third of which the said Nicholas J Battle is intitled, and which third is conveyed by these presents, the said third containing fifty four acres, being the same, more or less.

To have and to hold the said right, title, interest and claim to and in the before mentioned tract or parcel of land unto the said James W Battle, his heirs and assigns forever, clear from and against the lawfull right of all and every other person or persons whatsoever, shall and will warrant and forever defend by these presents.

Witnesseth, that the said James W Battle for and in consideration of the sum of One hundred dollars, hath bargained and sold unto the said Nicholas J Battle, his heirs and assigns forever, all of one certain tract or parcel of land, lying and being in the aforesaid County of Southampton adjoynig the lands of James Cobb and the said Nicholas J Battle containing one hundred and forty eight acres more or less; and is that tract or parcel of land allotted and set apart to the said James W Battle in the division of the lands of which his father, the late Wm R Battle died single, and professed in the state of Virginia. To have and to hold the said tract or parcel of land forever.
