Witnesseth that the said Mary Vick and Daniel Vick do grant unto the said Franklin Vick the following property, that is to say, Mary Vick do grant unto the said Franklin Vick with general warranty the tract of land on which she lives, and in which she has a life interest, also all her household and kitchen furniture - and the said Mary Vick & Daniel Vick do grant unto the said Franklin Vick with general warranty the following property, which belongs to them jointly, to wit, Trunkers, one head of cattle, seventy four head of hogs, together with their future increase, of dead horses, cattle & hogs - all the farming utensils - one still & fixtures, one apple mill, press, barrels &c. also all their growing crops of corn, potatoes, peas, potatoes, cotton &c. and any which they make this year. On trust to settle the following debts to wit, a debt due Benj. F.
