So far as the said warranty binds him to make good the title to the said 24 acres part of the tract aforesaid, the title to which is now known to be defective. This Indenture made this the 3rd day of August one thousand eight hundred and sixty five between Nathaniel Rawls of the County of Southampton and State of Virginia of the first part and Charles R Rawls of said County & State aforesaid of the other part, Witnesses: that the said Nath^l. Rawls in consideration of the sum of five hundred & sixty dollars, and have been paid by the said Charles R Rawls, which receipt is hereby acknowledged, have this day granted, bargained and sold, and by these presents do bargain and sell to the said Charles R Rawls his heirs and assigns forever, one tract of land lying in the County of Southampton and State of Virginia, near Poor Depot, situated on the Norfolk & Petersburg Rail Road, adjoining the lands of James B Wigham on the North and the lands of Wm^g. F. Bell on the east South and R. B. Rawls on the West, & others, containing One hundred and fifty acres more or less, To have and to hold the said tract of land with all of its appurtenances therunto belonging or in any way appertaining unto the said Charles R Rawls his heirs and assigns forever; and the said Nathaniel Rawls do by these presents forever warrant and defend the right and title of the said land to be good unto him, the said Charles R Rawls his heirs and assigns forever, clear from and against the laws, rights or claims of any third person or persons whatsoever, but the party of the second part further more agrees to furnish the party of the first part a maintenance for life on the said tract of land which maintenance is not to be forfeited or subject to executions.
