C Daughtrey purchased at public sale by order of Court of Stays here in 1828. for one hundred and ninety one acres (191), more or less, including about Six (6) acres belonging to the Rail Road Company - The tract of land is bounded by the lands of Parker D Story, James S Hollis heirs, Charles Roundtree, Zachus Stoyes heirs and John H Bishop, and all the estate, title and interest of the said Benj. C Daughtrey his wife either in law or equity, if in and to the said premises; Together with all the privileges and appurtenances to the same belonging, and all the rents, issues and profits thereof. To have and to hold the same to the only proper use of the said Sarah R Harrison, her heirs and assigns forever. And the said Benjamin C Daughtrey and Harriet Daughtrey his wife for themselves and for their heirs, executors and administrators, do hereby covenant with the said Sarah R Harrison her heirs and assigns, that they are the true and lawful owners of the said premises, and hath full power to convey the same; and that the title is clear, free and Unincumbered; and further that they will warrant and defend the same against all claims or claims of all persons whomsoever -
