

This Deed made the 19th day of October in the year 1864, between Joshua Bryant and his wife Mary Ann of one part and Samuel H. Griffin of the other part, Witnesseth: that in consideration of the payment of One hundred dollars in bank money and one buggy and harness, the receipt whereof is hereby acknowledged by the said Joshua Bryant and Mary Ann his wife do grant bargain and sell unto the said Samuel H. Griffin all the right, title and interest they have in a Certain tract or parcel of land recently purchased of the heirs of William Beale dec^d known as the "old Biggs place" and bounded on the North by the road leading from Musfus Depot to Synners Church, on the East by the road leading from Synners Church to Franklin Depot and the lands of M. H. & L. H. Griffin, on the South by the lands of M. H. & L. H. Griffin and on the West by said M. H. & L. H. Griffin and Mrs. Evelyn Drury, containing fifty one and one half acres more or less, excepting the right of Mrs. Beale heirs to one half acre measuring from the center of the grave yard, all of which will fully appear by reference to the record.
