This Deed Made this 20th day of October 1866, between Robert S. Barnes of Southampton County State of Virginia of the One part and Jas. Sillard of Jamesmont County State of Virginia of the Other part. Witnesseth that the Said Robert S. Barnes has, for and in Consideration of the Sum of Seven Hundred dollars Current Money of the U.S. the receipt of which is hereby acknowledged, bargained and sold unto the Said Jas. Sillard the tract of Land known as the "Simon Murfey farms" - Said tract is supposed to contain Seven Hundred and Fifty acres, be the same more or less, (surrounding however thirty feet square, the grave yard of Simon Murfey dec.) and adjoining the lands of Jacob Linn, J. B. Daughton, Thos. H. Cropp, Spellics Beale, Meredith Holland, and Alfred Cobb, the title whereof the Said Robert S. Barnes doth forever warrant and defend unto Said Jas. Sillard against the claims of himself and all other persons. - Witness my hand and Seal this the day and year above written. - Robert S. Barnes, (Seal)

Personally appeared before me a Justice of the Peace in and for the County of Southampton State of Virginia, Robert S. Barnes whose name is assigned to the above Deed and acknowledged the same to be his act & deed. - Given Under my hand and Seal this 20th day of October, 1866. - Joseph G. Crumpler, J. P. (Seal)

Barnes to James Sillard, was this day received and together with the Certificate thereto annexed of the acknowledgements of the Said Robert S. This Indenture Made this 7th day of December 1867, between Richard Barrett and Mary Rebecca his wife and Erastus B. Barrett of the County of Southampton and State of Virginia of the One part, and Samuel B. Picklow of the County of Southampton and State of Virginia of the Other part, Conditions. That for and in Consideration of the Sum of Seven Hundred dollars in hand and paid to them the aforesaid Richard Barrett and Mary Rebecca, his wife and Erastus B. Barrett, doth Sell to the aforesaid Samuel B. Picklow, One certain tract or parcel of land containing two hundred and Ninety acres more or less, to-wit: as the same owned by the heirs of William Webb deceased and formerly known as the Wells Murfey tract, and by land of Samuel B. Picklow, and by the land of James Wells Estate, the aforesaid tract of land being Situated in the County of Southampton and State of Virginia. The right
