This Deed made the 12th day of March Anno Domini 1869, between Arthur Whitley
& Lucy Whitley his wife of the first part, & John J. Kierstead of the second part,
Witness, that the said Arthur Whitley & Lucy Whitley do hereby grant & convey to the
said John J. Kierstead the following property, to wit, all that tract or parcel of land
on which the said grantors now reside, supposed to contain One hundred & thirty acres,
more or less, & bounded by the Lands of Richard S. Bryant, Thomas Corvitt's heirs, Calah
Corvitt's heirs, & others; One bay Mule, (Phillis) five head of Cattle, including one
work Ox, twenty head of sheep, & all the increase of the said Cattle, five feather
Ducks, & furniture, & all other household & kitchen furniture, all the said Whitley
farming implements, including one Cart & Wheel, by Cash, to the second the
payment of @ least for One hundred dollars, and to Joseph St. Barbara & of
exec date with this Deed, to which the said Richard S. Bryant is Surety.

County, both present together, the within named James Lucy Whitley, wife of Arthur Whitley,
pursuant to the within Sub. dated March 12th A. D. 1869, & being examined by
us privately & apart from her husband & hearing the said Deed fully explained to
her, she the said Lucy Whitley, acknowledged that she had willingly executed
the said Deed & that she did not wish to retract it. And we do further certify
that the said Arthur Whitley afterwards, to wit, on the same day, also acknowledged
the said Deed before us in our said County & requested us to certify the said to the

This Deed made the 30th day of December in the year 1868, between Daniel St. Helms
Grantor appointed regally by the County Court of Southampton County at the November Term
in 1868, in the place of Jesse Sankford S. D. who was original trustee, in C
Cordons Land of trust established by Willis Brown for the benefit of Cary Brown, wife
of the first part, & John Brown of the second part, Witness, that in Consider-
ation of \$1500. (Fifteen hundred dollars), the said Daniel St. Helms, Trustee of
the first part, doth grant convey & release unto John Brown of the second part,
all right, title & interest whatever in @ certain piece or parcel of Land known
as the Willis Brown tract, lying in the County of Southampton & State of Virginia,
containing by estimation about 230 acres, more or less, & bounded on the
North by Lands of Irwin W. Sucke, & Daniel St. Helms, on the East by
