Neale Lewis, Henry Brown, (now) and by the land recently laid off for Sally Brink & her children by Commissioners acting under & Seals of the Court of Southampton County, delib^rately bound 1858. To have & to hold the above described tract or parcel of Land and premises with the appurtenances thereto belonging or in any wise appertaining unto him the said Miles Worne his heirs & assigns for the full term of fifty years, as aforesaid, which will end on the 31st day of December A.D. 1907. And the said Burkhardt S. Barkman, Martha J. Barkman his wife & Margaret A. Dudley, for themselves, their heirs, executors & administrators, do hereby covenant & agree to & with the said Miles Worne, his heirs, executors, administrators & assigns, that they will by these presents warrant & defend all the right & title of the aforesaid tract or parcel of Land & premises during the aforesaid term of fifty years against the claims or demands of all & every other person, & persons whatsoever.
