The Due (2) made this 6 day of April in the year one thousand eight hundred and seventy two (1872) between Lewis E. Mann & Elizabeth Mann his wife, both of the County of Buckingham
 this and state of Virginia, of the one part, and Joseph B. Davis, of the said town, in state
 of the other part. Whereas it is the said Lewis E. Mann and Elizabeth Mann, do
 jointly with the said Joseph B. Davis the following paying to Wm C. Collier their
 of land containing by record survey 177.75 acres lying 3 miles on the said County
 of Buckingham, and bounded as follows: to the east by the main road from Mann's Mill
 Landing to the east of the public road, from C. bridge over Elk Creek running
 to Pleasanton bridge, to the south by a tract of land belonging to the estate
 of Jas W. Clark and to the west by a tract of land belonging to Thomas M.
 Edwards. The said Lewis E. Mann & Emma E. Mann of the family of Wilmington in state
 of Virginia, the payee of C. Collier their executors by the said Lewis E. Mann
 having date at the 6 day of April 1872, and being paid the sum of \$1000
 hundred and no cents for lottery #37571 in the 6 day of April 1872, in
 kind of common land and agreed between the parties aforesaid, that in case of C.
 sale the same shall be made after forty days advertising the same, place & time
 having for thirty (30) days, a general public place in the County of Buckingham, and
 in Hillsboro, Virginia, by their self, or upon the following day, in case
 for C. day as to the property of the payee of C. may be required to defray the
 expense of executing the same, the fee for drawing and recording the Deed,
 of the Deeds, and the disbursements amount of money principal of interest,
 and payable, upon the said land, and of those to any other of said land purchased
 during the same shall be liable payable to such sum, and to be recovered in such
 manner as the said Lewis E. Mann, his executors, administrators or
 assigns shall present and demand, and in case of his or their death, in
 case such debtors, at such time, are in such manner as the said Joseph
 B. Davis shall stand for the said debts to appear to pay the same, expenses
 due, and charge upon the said property hereby named, & long as he or his heirs
 or assigns shall hold the same. The grantee C. Collier to warrant personally the
