Williams for and in consideration of one thousand dollars, one grant bargain and sell unto the said Jacob Williams all her house hold and kitchen furniture, stock of every description, farming implements, Crops of every description together with certain part or parcel of land situated in the County of Southampton and State of Virginia containing about hundred and thirty six acres (more or less) bounded by the lands of W. S. Adams, Dr. H. Clark, for said William that all the above property is to remain in my possession and control during my natural life. The said Henry J. Williams covenant with the said Jacob Williams to warrant generally the title to said property. Witness the following signatures and seal the day and year above written.

This Deed made the 29th day of May A. D. 1874 between William Boyant and Marinda Francis Boyant his wife of the first part, and Moses Jones, Reuben Allen, Wade Banks, John Dyer, Charles Turner Trustees for Baptist Church of the second part. Whereas that for and in consideration of the sum of eight dollars - to them in hand by the parties of the second part, the receipt of which is hereby acknowledged, they the said parties of the first part, have given, granted, bargain, sold and conveyed unto the said present, give, grant, bargain and sell unto the said parties of the second part as Trustees for a Baptist Church, ten acres of land lying and being in the County of Southampton State of Virginia, and being a part of the tract or parcels of land now resident and said ten acres land is on the south side of corner that divides the land of Col. Tho. Relfy, John Sharp, deceased, and said Wm. Boyant and said ten acres land bounded as follows, to wit: said Wm. Boyant's tract back out to the public road called the December road, and said tract and said tract north and bounded out forty yards in straight line to a state, and from said state in straight line back to another state, and from the latter state in straight line out to the said above hundred, and along said state back to the starting point. The portion of the first part sold and conveyed, the above described ten acres land to the parties of the second part, as trustees to erect a Baptist Church on the same. And the said parties of the first part covenant to warrant and defend forever the premises hereby conveyed, against the claims of any and all persons whatsoever.
