

Delivered to C.C.V. 9 Aug 1774

This Deed made and executed this the 22^d day of July 1774 between Jno. Arroyo vs. Petronio de Noe Delator, of the County of Southampton in the State of Virginia of the first part, and Thomas de Noe of the said County and State of the other part whereas the said Jno. Arroyo by virtue of a deed of trust made and executed in the Clerk's Office of Southampton County adjoining said Arroyo against the heirs of John J. Arroyo and Jacob A. Hamblett did on the 17th day of July 1774 agree to purchase the tract of land belonging to the Petronio, namely purchase of the same, and that Thomas de Noe became the purchaser for one hundred and thirty five dollars. Witness the receipt of which a barely acknowledged have assigned and sold and by these presents a good and convey unto the said party of the second part, their heirs and assigns forever, all that certain parcel or parcel of land lying near Frank's Bay District Southampton County &c. adjoining the lands of Peter Coll. Jno. Gregory and others and described as follows, beginning at the Stone mark and a post or corner for the tract and John Pickett as he charges, then to S 27° W 2 1/2 G. 75 then to a post or corner for the tract of Jno. Pickett, thence S 62° 3/4 W 3/4 G. 25 thence to the top one of the 533 3/4 G. to a line to be established there along the said creek to the post at beginning containing five acres more or less. Begined with all the estate title and interest of the said party of the first part them and the said party of the first part agree with the party of the second part to witness and defend the above granted premises in the spaces full possession of the party of the second part their heirs and assigns forever.
