

Know all men by these presents, that J. Eliza J. Branch of the County of Southampton and State of North Carolina, for and in consideration of the sum of Six hundred dollars to her paid by R. P. Ellis of the County of Southampton and State of Virginia, the receipt whereof is hereby acknowledged, do give, grant, sell and convey unto the said R. P. Ellis all of a certain piece or parcel of land lying in Southampton and bounded as follows, to wit: to wit by Charles Brant's land, on the East by the Deacons and the Road, on the West by Miles H. Hillman and John H. Morrison's land, and on the South by Carr Richard's land, containing thirty acres more or less, to have and to hold the same to the said R. P. Ellis, his heirs and assigns, to his and their use forever. And I the said Eliza J. Branch, do warrant unto the said R. P. Ellis, his heirs and assigns that I lawfully signed in full of the premises, that they are free from all incumbrances, that I have a good right to sell the same as aforesaid and that I will warrant and defend the same to the said R. P. Ellis, his heirs and assigns against the lawful claims and demands of all persons. Given under my hand and seal, this 15th day of March 1875.

 This Deed of Bargain and Sale from Eliza J. Branch to R. P. Ellis was this day read and found by the clerks of R. H. Morrison and M. H. Hillman to be true and lawful and admitted to record.

This Deed made this 15th day of March one thousand eight hundred and seventy five between Richard P. Ellis of Southampton County of the one part and Dr. J. Morrison of the said County of the other part, Testimony: that the said R. P. Ellis did grant unto the said Dr. J. Morrison the following property to wit: A certain tract or parcel of land lying in Southampton County, and bounded as follows, to wit: to wit by Charles Brant's land, on the East by the Deacons and the Road, on the West by Miles H. Hillman and John H. Morrison's land, and on the South by Carr Richard's land, containing thirty acres more or less, of Southampton County to the said Dr. J. Morrison, the payment of a note, drawn by the said R. P. Ellis bearing date with this deed and payable to the said Eliza J. Branch or order twelve months after date being for the sum of Seven hundred dollars, of a certain land located by the said R. P. Ellis having date the 15th day of March and being for the payment of Seven hundred dollars. And it is covenanted and agreed between the parties aforesaid that in case of a sale the same shall be made after first advertising the land, place and terms thereof for thirty days at the Court house door of said Southampton County, and upon the following day to wit: for such as to be made of the proceeds as may be necessary to repay the debt of securing this tract, the fee for drawing and executing this deed if there be any and to discharge the amount of money for principal and interest then payable upon the said note and if there be any residue of said purchase money the same shall be made payable at such time and in such manner as the said R. P. Ellis, his executors, administrators or assigns shall provide and direct or in case of his or their failure to give such direction at such time and in such manner as the said Dr. J. Morrison shall think fit. The said R. P. Ellis covenanted to pay all legal expenses, charges, interest and charges upon the said property
