 property to wit: One bay mare and several hares, ears and wheels & hares  
 hags, farming implements of my description and of my wife of Corin  
 Corcoran, Deeds, pounds 80 raised and gathered during the year 1875.  
 (After satisfying my debt) in trust to Robert Corcoran & Company in a debt due  
 by land for the hundred and forty dollars and fifty cents (Five. 00) dated  
 June 1<sup>st</sup> 1875 and payable 1<sup>st</sup> December 1875, and also in trust to Robert  
 Corcoran in a debt due by land for Twenty five dollars and thirty  
 five cents dated June 1<sup>st</sup> 1875.
