This Court would this 23rd day of November in the year 1774 between John Griffith Sr.
and Con D. his wife, John Coll and Maribha his wife and James T. Coll of the County
of Southampton and State of Virginia of the first party and Anthony Brantley of the
County and State of the second party, Merchants, shab for and in consideration of the
sum of One Hundred and fifty dollars to them just paid the receipt whereof
is hereby acknowledged they the said parties of the first party do grant bargain and
convey unto General warranty unto the said Anthony Brantley party of the
second party, Neely certain lot of lands lying in the town of Dranklin and within
the City of Northwic they are bounded by a line beginning at the intersection of
Shirley Avenue and Northwic Street thence Norwesterly along Northwic Street about
310 feet to French Avenue, thence Norwesterly along French Avenue about 50 feet to
Mrs Sarah Bennetts lot thence Norwesterly along the line of Mrs Sarah Bennetts lot
about 310 feet to Shire Avenue, thence Easterly along Shire Avenue about 50
feet to Northwic Street, the point of beginning, containing by estimation a little less
than one acre of land according to the Map of Dranklin, to have and hold
the said lot of land to him the said Anthony Brantley his heirs and assigns forever.
