

This Deed made this 15<sup>th</sup> day of October in the year 1875 between J. Hiley Friends Commissioner appointed for the purpose hereinbefore mentioned of the one part, & D. S. Moore of the City of Radford South Carolina of the other party, Testis this wherein at the July Court 1873 of the County Court of Radford Co., it was among other matters ordered and decreed set the seal of Radford, Virginia for Dr. J. Hiley Friends "Whale tail" and J. Hiley Friends and J. C. Hartwell, who for the above appointed Commissioners, after one of whom might ask witness with him should be to proceed to sell to the highest bidder, and the manner and on the term contained in such order and who being present had said estate referred to Moore, and Moore had said J. Hiley Friends, and that the sum of one thousand dollars and no cents did not take 15<sup>th</sup> day of December 1873, for each to till the ground according to request, and while said D. S. Moore became the proprietor of said house and land, to have the legal bidder therefor having bid the sum of \$750.00 and above, etc. deuterum term 1874, of the Circuit Court of Radford County, to which last mentioned land the soil and has been secured by operation of law, the sale of the said estate of ground and improvements, and said J. Hiley Friends appointed Friends to collect the purchase money from said said estate which has now been fully paid, and whereas at the September term 1872 the Hiley Friends, was appointed a special Commissioner for the purpose and ordered as aforesaid to convey by present deed with special warranty and at the date of the grantee not the said D. S. Moore the legal title to his tract of land, hereunder by hand delivered. Wherefore for and in consideration of the premises, and of the sum of the sixteen, six hundred and four by the said D. S. Moore, to the said J. Hiley Friends, special Commissioner, he will, who is herby acknowledged, the said J. Hiley Friends, special Commissioner aforesaid, will grant and convey unto the said D. S. Moore, with special warranty the following property to wit. One two certain tracts or parcels of land lying and being in the County of Radford in the state of Virginia, adjoining each other and containing one entire tract or parcel of land containing altogether ten hundred and forty acres, more or less, formerly owned by one Samuel Cook of Radford County, which is the County of Cook became the property of Wm. Cook and Martha Lammey deceased, etc. also the wife of James Givens of Radford County, North Carolina, and afterwards became the sole property of the children of the said Martha Lammey, which said Givens family had of land, on the south side of the mountains and Roanoke Red Road and without doubt the mill of Rogers' Mill, and is bounded by the lands of C. C. Sneed, the son of Dr. J. C. Sneed, who owns of Lewis' Creek, Givens, and a tract of land called the Hill place, one acre or so described by one Colcord's brother.
