That we made and entered into on the 30th day of March 1775 between George May, and Rosewell S. Mayes and wife his heiress of Southampton and Hampshire Counties, State of Virginia, of the one part and Horatio S. Mayle and his wife for and in consideration of the sum of two hundred and fifty dollars to him in hand paid have granted, bargained and sold and by these presents, he grant, bargains and sells unto the said Horatio S. Mayle his heirs and assigns forever, and certain tract of land situate and lying in the aforesaid County of Southampton, containing by estimate one acre and a half, situate a part of a tract of land known as the bounded tract of James Mayes deceased, and bounded as follows: East and south by the lands of Henry Pace deceased, and also by the State line north by the lands of David Mayes deceased, commencing at or abo the south a black oak tree standeth. A Carolina tree some hundred yards to a lighted oak, thence North some eighty yards to a light oak, set in abo the road, thence down the road some hundred yards to the beginning. So far and to hold the above described tract or lot of land with its appurtenances, to have belonging unto the said Horatio S. Mayle his heirs and assigns forever, and the said George A. Mayle and Rosewell S. Mayes and his wife for themselves, their heirs, executors and administrators, as hereby, warrant and forever defend the right and title of the aforesaid tract or lot of land against the claim or demands of all such every other person or persons whatsoever.
