This Deed of Trust made this 29th day of January 1797, between R. P. Ellis
and Rebecca Ellis his wife the grantors of the first part, and Joseph A. Brown the
grantee of the second part, containing the sum of one dollar, part of
the purchase of the first, by the trustee, the receipt of which is hereby acknowledged, the
parties of the first, do stand and convey with general warranty, to the said Joseph A.
Brown the trustee, the following land situate, lying and being in Southhampton County
Virginia, situate at Branchville Nevers on the S. & R. Road, containing thirty and
three fourths acres or less, and bounded on the south by the lands of the S. & R. Road
be. bounded on the north by the lands of M. C. Wick and J. W. Corbitt; bounded on
the east by the lands of J. W. Corbitt and bounded on the west by the lands of M. C.
Wick and John H. Kinnison. Do stand however to secure the payment of a note
of seven hundred and thirty four dollars, due to J. Brown and W. H. Kinnison former
trustee under the name and stamp of J. J. Brown & Co. in the full 9th and with date
bearing and date with this date. It is agreed by all the parties to this writing that
if the said R. P. Ellis within one year from this date pays one half of said note and interest
due to J. Brown & Co. then they agree to give him ten years from this date to pay the
