hundred and eighty four dollars to us in hand paid by the said D. A. Kitchin, the receipt
of which we do hereby acknowledge, have bargained, sold, conveyed, and by these presents
do hereby bargain, sell and convey to the said D. A. Kitchin the land and appurtenances all that certain
parcel of land situated on the south side of the R. R. Road and north side of the County
Road leading from Jerusalem to South Quay in the County of Southampton State of Virginia
adjoining the lands of the said D. A. Kitchin and others, bounded as follows: beginning
