 Virginia M. his wife, grantors of the first part and Wells E. Daughtrey, executor
 of the estate of Southampton State of Virginia, of the second part, test-
 aments: that in consideration of the sum of two thousand two hundred and
 fifty dollars, paid by the said Wells E. Daughtrey unto and to the said Luther
 L. Edwards and Virginia M. his wife, the receipt whereof is hereby acknowledged,
 they the said Luther L. Edwards and Virginia M. his wife do grant with general
 warranty unto the said Wells E. Daughtrey the following real property to-wit:
 the half of a certain lot or parcel of land lying in the town of Southampton and
 bounded as follows: and the land by virtue thereof, and the title by the hotel
