And of This Agreement entered into this 25th day of April 1877, between James J. Dandred of the first part and William Crowley of the other part, witnessed at Southampton County, that whereas the said W. H. Crowley is about to engage in the cultivation of the soil and desires to obtain supplies during the year 1877, James the said Jas J. Dandred for the amount of two hundred dollars and two dollars and fifty cents for executing this agreement and taking the acknowledgments, and the said Jas J. Dandred having agreed on his part to furnish said supplies, now this said W. H. Crowley on his part in consideration of the above provisions doth hereby grant a loan to the said Jas J. Dandred on his credit of all kinds made on W. H. Crowley's hand this year 1877, and on which said Crowley now owes for the amount advanced to him this year which has been or was intended to have been expended and the said Crowley finds himself agreeable to have to deliver enough of said crops mentioned to Jas J. Dandred at Newmarket North 25th by or before the 1st day of December next to pay said advances. This loan is quoted under an act of the General Assembly of Virginia approved April 25th 1876, entitled an act to secure the advances for agricultural purposes.
