And this Agreement entered into this 20th day of April 1877, between James J. Darden of the first part and William Buckley of the other part, witnessed at Southampton County, that whereas the said W. Buckley is bound to engage in the cultivation of the soil and desirous to obtain supplies during the year 1877, from the said Jas J. Darden for the amount of two hundred dollars and two dollars and fifty cents for executing this agreement and taking the acknowledgments, and the said Jas J. Darden having agreed on his part to furnish said supplies, now the said W. Buckley on his part in consideration of the above provisions doth hereby agree to lend to the said Jas J. Darden on his credit all kinds of goods on W. Buckley's hand the year 1877, and on which said Buckley was liable for the amount advanced to him last year which has been or was intended to have been repaid and the said Buckley finds himself agreeable to law to deliver receipts of said goods mentioned to Jas J. Darden at Newmarket North 2nd by or before the 1st day of December next to pay said advances. This law is quoted under an act of the General Assembly of Virginia approved April 20th 1876, entitled an act to secure the advances for agricultural purposes.
