Now therefore, in consideration of the sum advanced and further advanced to be made from time to time, and in further consideration of and other to the said Solomon Jones paid by Jas Mc Corbitt the receipt of which is hereby acknowledged the said Solomon Jones hereby covenants and agrees that the said advances shall constitute a lien upon all the crops of every description growing and to be planted and grown to the said Solomon Jones upon the said Jack Whitehead place during the year 1878, to have and to hold for the following purpose to wit: That the said Solomon Jones should pay on or before the 1st day of December 1878 to pay said debt then the said Jas Mc Corbitt shall after ten days notice of three parties placed in said county sell all the property owned or owned for cash, and out of the proceeds pay said debt, interest and cost, and a balance of such proceeds pay over to the said Solomon Jones or his assigns.
