This deed made this 2nd day of February in the year one thousand eight hundred and twenty nine between Stith D. Spivey of the one part and Mr. Wm. F. Bradshaw of the other part witnesseth that the said Stith D. Spivey doth grant unto the said Wm. F. Bradshaw Trustee the following property to wit: One certain tract or parcel of land it being the said tract in the said Stith D. Spivey now resides containing six acres more or less bounded by the lands of W. F. Bradshaw and the swamp & ditch field and boundaries as he trust to secure the payment of the sum of one hundred and twenty seven dollars in ^{and} security three cents (\$27.33) due by bond to W. F. Bradshaw of the date, to the intent that payment shall be made in payment of the above mentioned Bond then the trustee on being required so to do by W. F. Bradshaw or his successor or assigns shall sell the property herein described. And it is covenanted and agreed between the parties aforesaid that in case of a sale the same shall be made after first advertising the time, place and manner for twelve days and when the following terms to wit: For cash as to so much of the proceeds as may be necessary to defray the expenses of executing this trust the fees for drawing & recording this deed if the same be recorded and to discharge the amount of money then payable upon the said bond and if there be any residue of sale price over money the same shall be made over at such time and in such manner as the said Stith D. Spivey his executors, administrators, assigns shall prescribe and direct or in case of failure to make such donations at such time, place or manner as the said testator or either of his co-heirs to all taxes assessments dues and charges upon the property herein conveyed as long as he or his heirs or executors be the owner.
