 at the year of our Lord 1846 between J. D. Pritchett & myself
 & his wife Mary H. Pritchett, Sarah D. Pritchett, Julie L. Pritchett
 Samuel B. Pritchett & Mary H. his wife of the County of South-
 ampton State of Virginia of the first part & Abn L. Gardner
 of the County of Franklin State of Virginia of the second
 part witnesseth that the said parties of the first part
 for consideration of the sum of Two hundred dollars
 to us in hand paid by the said Abn L. Gardner the re-
 ceipt of which we do hereby acknowledge both bargained
 sold & conveyed & by these presents doth bargain sell &
 convey unto the said Abn L. Gardner his heirs & assigns
 a lot of land in the village of Franklin fronting on
 Clay St located as follows: beginning at a point on
 the west side of Clay St 533 ft S in 59 $\frac{1}{4}$ ° E from the jun-
 ction of the west side of Clay St with Corporation Lane
 at Beaman's corner thence along Clay St 147 ft S 59 $\frac{1}{4}$ ° E
 thence 300 feet S 30 $\frac{3}{4}$ ° W thence 147 ft N 59 $\frac{1}{4}$ ° W thence
 200 ft N 20 $\frac{3}{4}$ ° E to point of beginning along — Et together
 with all the privileges appurtenance thereto belonging or in
 any wise appurtenant unto him the said Abn L. Gardner
 his heirs & assigns forever. Moreover we the said party of
 the first part doth covenant & agree to & with the said party
 of the second part that after the delivery of these presents
 he warrant & secure the right & title of the aforesaid
 lot of land unto him the said Abn L. Gardner his heirs
 & assigns against the claims of any & all manner
 of persons to all intents & purposes whatsoever. In witness
