This deed made this 21st day of September one thousand eight
hundred and twenty eight (1878) between Fannie Stephenson, wife
of James W. Stephenson his wife, of the first part, and
Richard N. Bailey, of the second part, witnesseth, that in consideration
of the sum of Five hundred Dollars (\$500⁰⁰) the said
Fannie Stephenson, Lewis W. Stephenson and Elizabeth S. Stephenson his
wife do grant unto the said Richard N. Bailey, with general warrant
all of their right title and interest in a certain piece or parcels
of land containing one hundred and fifty acres more or less, it
being a portion of the lands owned by the said Fanny Stephenson
as Lewis W. Stephenson lying near the Village of Berlin Berlin
