This Deed, made this 25th day of September in the year one thousand eight hundred twenty eight between James B. Lewis and Mary Jane Lewis his wife of the first part and Robert Gregory of the second part, witnesses that in consideration of the sum of five hundred (\$500) to have, the said James B. Lewis and Mary Jane his wife do grant unto the said Robert Gregory with General Warranty, all a certain tract or interest in a certain piece or parcel of land, containing one hundred acres, more or less, situate a portion of the land, bought by J. B. Lewis of A. M. Edwards and bounded as follows, on the north by A. S. Nelson, commencing at a oak post a corner between Mary Susan Edwards, A. S. Nelson, then or north along A. S. Nelsons line to a persimmon tree, a corner tree between A. S. Nelson and Clara Deale, then south by marked trees to Henry Clays line, then east along a line of marked trees to a pine, near fish ground field, then or to a sweet gum near Black water - or a, then down the Black water road to a pine tree, then a trail, cross the road to a oak post at the beginning of a portion of said land to be in the 25th day of December 1896.
