This Deed made the 25th day of September in the year one thousand eight hundred and forty-eight between James P. Lewis and Mary Jane Lewis his wife of the first part and Robert Drown of the second part witnesseth that in consideration of the sum of Two hundred (200-) Dollars, he said James P. Lewis and Mary Jane his wife do grant and convey to Robert Drown with General Warranty, all a certain tract of land situated in a certain piece or parcels of land containing one hundred acres more or less, it being a portion of the land bought by Jas. P. Lewis of R. M. Edwards and bounded as follows on the west by A. L. Edwards commanding at a oak post corner between Mary Jane Edwards, A. N. Nelson, fence north along A. L. Edwards line to a pine tree, a corner tree between A. L. Edwards and Sam. Reid three bush by marked trees to Henry Ely's line, thence east along a line of mark trees to a pine near fresh ground field, thence to I. Welch's ground Black water road, thence down the Blackwater road to a pine tree, thence straight westward to a oak post at the beginning of possession of said land to be on the 25th day of December 1878. He said James P. Lewis and Mary Jane his wife covenant that they do their right to convey the said land to the grantee, that they have done no act to encumber the said land, that the grantee shall have quiet possession of the said land free from all encumbrance, and that James P. Lewis and Mary Jane his wife parties of the first part will execute such further assurances of the said land as may be required, witness the following signatures and seals.
