This Deed made this 1st day of January 1878 between Henry C. Moore of the one part and E. G. Story of the other part, witnesseth that the said Henry C. Moore doth grant unto the said E. G. Story one tract of land lying in the County of Southampton bounded by the bounds of Dennis Moore, John D. Miller and Isaac P. Cather and others known as the Samis place, containing one hundred and twenty acres more or less, being the land upon which said Henry C. Moore now resides. It is trust to secure First sum bound ex-
 ecuted by said Henry C. Moore to Nancy McElroy bearing date the 1st day of January 1878 for the payment of One Dollar and Eighty cents on the 1st day of July 1878 and at the expiration of every six months thereafter, during his natural life. Second sum to secure one bond executed by Henry C. Moore to John Ellis and Sarah his wife for one hundred and twenty Dollars bearing date the 1st day of January 1878 on demand twelve months after the decease of Nancy McElroy with interest from the day of her decease and then bond of said date and same amount on demand two years after the decease of Nancy McElroy with interest from the day of her decease, and another bond of the same date and amount on demand three years after the decease of said Nancy McElroy with interest from the day of her decease, witness the following signature and seal.
