Branch his wife of the other part witnesseth that in consideration of the natural love and affection that we said W. W. Branch and Sarah P. Branch his wife have for the spouse Margaret D. Branch and such children as may be born unto them the said W. W. Branch and Sarah P. Branch his wife do hereby give and bequeath unto the said Margaret D. Branch our such living children as shall be born unto one certain piece or parcel of land containing Twenty five acres more or less bounded on the north by the S. D. Rykyn on the south by W. W. Branch in the east by D. R. Nichols or the west by the said W. W. Branch all of said lands are designated by marked trees road and lane - the condition of the deed are as follows Should the aforesaid Mrs. Branch die before Margaret D. Branch his wife She is to hold the same during the time she remains his widow, in case she marries She forfeits all right in the said lands and to be the property of the said Mrs. D. P.
