Urganhart trustee as above said in consideration of the purchase of the sum of three hundred dollars to him in hand paid, receipt whereof is hereby acknowledged, has given granted conveyed & sold & has by these presents given granted conveyed & sell with the said Wm Henry Hamlin with special warranty all of a certain tract or parcel of land lying & being in the County of Southampton, bounded by the lands belonging to the estate of B. S. Briggs to the estate of George Glover & the lands of said Urganhart containing sixty seven acres more or less beginning at the junction of the Mill Swamp & Brister's Branch thence along a chopped line one foot to a Red oak thence S. 80° E. to a pine near the front of Hamlin's house thence S. 75° E. to a pine near a barn (the barn since burned) thence down said bank to the Mill Swamp (the line between Below & Urganhart) thence down the Swamp to its junction with Brister's Branch the point of starting to have to hand the said Wm Henry Hamlin & his heirs forever.
