Examined This Deed made this 10th day of December A.D. 1878, between Thomas J. Pettow Commissioner of the first part, and John Pettow junior of the second part, both of the County of Southampton State of Virginia, witnesses and presence: Whereas the said Thomas J. Pettow acting in pursuance of a Decree of the Circuit Court of said County, rendered up the 14th day of May A.D. 1878, in the suit of John Pettow Jr. vs. John Pettow Jr. as Commissioner as aforesaid, did heretofore sell certain real estate lying in the town of Franklin in said County, and the said John Pettow Jr. became the purchaser of certain lots or parcels thereof for the aggregate sum of Twenty four hundred and sixty dollars (\$2460.00 cents); And whereas by a subsequent Decree of the said Court, in the said suit, rendered at the 1st November term A.D. 1878, the said sale was confirmed, and the said Commissioner was ordered to collect the said purchase money, and to execute a Deed granting the said real estate to the said purchaser; And whereas the said John Pettow Jr. has fully paid the said purchase money, principal and interest to the said Commissioner, the receipt of which said sum is hereby acknowledged;
