Four Hundred (\$400.00) Dollars, the said James B Lewis
and Mary Jane Lewis, his wife do grant unto the said
William Henry Eley with good warranty, all and
their right title and interest to a certain piece or parcel
of land, containing fifty five acres more or less, it being
a portion of the tracts bought by James B Lewis of D. C.
Edwards, and bounded as follows, on the north in part
by the Black water road, to a sweet gum near corner
of east end of first ground, thence south to a pine
tree next to Pitcaughy Johnson's line, thence south to
a cedar Edwards line thence along Oak in Ely's line to
Henry Eley's line, thence along Henry Eley's line to
a Holly a corner on Ely's line a Edwards line, thence
along a line of marked trees to a pine on Blk. 4.
