This Deed made this first day of January in the year 1879, between R. B. Griffin trustee party of the first part, L. C. Vaughan party of the second part and Peter C. Cobb party of the third part, all of the County of Northampton and State of Virginia: Whereas by a deed dated the 1st day of January 1873 and of record in the Clerk's Office of the County Court of Northampton County, the said Peter Cobb in order to secure the payment of a certain bond bearing date on the 1st day of January 1873 for the sum of one thousand dollars, and payable on demand to John Pullen Jr. J. D. Pullen and S. B. Pullen did convey unto the said R. B. Griffin trustee that certain tract or parcel of land lying in the County of Northampton and State of Virginia, and bounded by a line commencing at a square cedar tree on the east side of the South Quay and Franklin roads, which is chopped or standing a few feet from the intersection of Daugherty's old Boggy track and the said road, thence N 55° E 7.99 chains, thence N 66° E along the County road until the old Gardner line bore said road, thence along the old Gardner line 22 chains thence N 50° W 50 links to the centre of the County road thence N 68° E 8 chains, thence N 89° E 7.99 chains to a point on said County road defined as the eastern corner of this tract, thence S 15° E along a line of marked trees 10 chains to a gum in swamp, thence N 52° W 2.95 chains, thence S 45° E 11.3 chains, thence S 71° W 4.77 chains to a black gum on a private cart path leading from South Quay to the above said County road, thence S 3° W 25 chains, thence
